

AGENDA ITEM 11 - CLERK & FINANCIAL OFFICER'S REPORT.

1.INTRODUCTION

It is customary for the Clerk & financial Officer to place proposals before the Council, at its annual meeting, in respect of the Chairperson' allowance and telephone allowance; the Clerk & Financial Officer's salary and telephone allowance.

2. CHAIRPERSON'S ALLOWANCES

The allowance is presently set at £1290, (This comprises a basic allowance of £620 and a telephone allowance of £670) in 2009/10 the allowance was frozen at its present level. Members are asked to consider what changes if any should be applied to the Chairman's allowance.

Members should note that the Independent Remuneration Panel of Wales considers Town and Community Councils in its Annual Report and this sets recommended values for the payment of allowanced to elected members and Chairs. As members are aware as no general allowances are paid by New Tredegar Community Council, therefore members need only be mindful of the payments made to Chair. The provisions of the Independent Remuneration Panel allows that Town and Community Councils can pay a civic allowance to chairs of any amount that is deemed appropriate to allow them to undertake their duties.

Therefore the current arrangement is considered acceptable under these provisions.

Members are asked to consider whether to apply any amendments to the current allowance paid.

3. CLERK & FINANCIAL OFFICER'S SALARY & ALLOWANCES.

The current salary is £ 2900 per annum. A payment of £100 per quarter is also made to cover telephone, broadband and office accommodation.

It should be noted that no cost of living inflationary increases have been applied to this payment since 2012. The Local Government employers paid an increase to Local Government officers in 2013, 2014, 2015, 2016 and 2017 but no increase has been approved by this Council in this time period.

The clerk is an employee of the Council whose members must be aware that all relevant employment law conditions are complied with. The Council can pay the Clerk and Responsible officer any wage it determines fit provided that it is above the National Minimum Wage.

The pay award agreed by Unison and NJC in 2017 is 1%.

Members are asked to consider what level of pay award is to be applied to the salary.

AGENDA ITEM 10 -MEETINGS CYCLE.

1. INTRODUCTION

It is customary for the Clerk & financial Officer to place proposals before the Council, at its annual meeting, in respect of the meeting cycle for the next year.

2. Bank Holidays 2017

In general meetings of the Council are held on the second Tuesday in each month. In 2017/18 bank holidays are as follows:-

New Year's day 1.1.18 (Monday), Good Friday 30.3.18, Easter Monday 2.4.18 May day 7.5.18 (Monday) Spring bank holiday 28.5.18, (Monday), Summer Bank holiday 27.8.18 (Monday) Christmas day 25.12.18 (Tuesday) Boxing Day 26.12.18 (Wednesday).

If the standard meeting cycle is continued then the AGM would be due to fall on the 8.5.18 which the Tuesday is following a Bank holiday Monday. Generally these days are avoided to reduce the chances of clashing with holidays etc. to ensure that as many members as possible can attend. It is proposed that as an alternative the 15.5.18 is adopted as the date of the AGM.
