Cllr Stenner delivered a verbal request from St Dingats for a second flagpole to enable the church to fly the Welsh Dragon as well as the Union flag. This was estimated as a cost of £1000, and they were requesting £500 as they were requesting match funding from other sources.

Discussion took place around the turbine fund. It was reported that the many groups had applied and had received monies from the fund.
