### 3867 To review projects

It was reported that members had met with the contractor proposing to bid for the festive lighting. There were currently 14 motifs, and there were old lights on Phillipstown School, even though they had not been used for several years since electrical works at the school affected the power supply. It was suggested that this could be reinstated to allow these lights to be reused but would depend on the school and whether the power supply could be reconnected.

The St Dingats site was inspected and a quote will be issued for this site, however consultation with the Church authorities will be required once the quote has been received.

At the time of the visit the Brithdir display had not been erected so a quote will be supplied even though this may not now be required.

Other Christmas activities that could be set up were discussed such as lantern workshops and a parade, issues such as traffic management were raised as a potential difficulty in relation to a parade but consideration could be given to workshops or restricting locations away from roads. Other issues such as the Father Christmas Sleigh and members were asked to give some thought to these proposals any bring any other ideas to the next meeting for further discussion. It was stressed that nay plans would need to be set up in a reasonable time frame and not left too close to the festive period to organise.
